Should the film/program shown in television turns out to be different in any manner from that as reviewed and approved by the MTRCB due but not limited to insertions, intercalation or additions thereto, I understand that the MTRCB has the authority to immediately stop the continued showing of the said film/program in any television channel;

I agree to conform to all requirement of review and classification of the aforesaid film/television program as a condition precedent for the issuance of its Permit to Exhibit, violation of which shall hold me administratively and criminally liable under Presidential Decree No. 1986 for such violation.
