The annual Metro Manila Film Festival (MMFF) will run from 25 December 2016 to 03 January 2017. During the MMFF festival period, the privileges of all Board Deputies, including the Local Regulatory Council (LRC) Volunteers, to monitor the public exhibition of motion pictures in the cinemas are suspended.

However, pursuant to Section 13 of P.D. 1986 defining the Board's power to inspect all public exhibitions of motion pictures, and in the light of its authority to exercise such powers and functions as may be necessary or incidental to the fulfillment of its mandate, the incumbent Members of the Board, including the Chairperson and Vice Chairperson, and its organic personnel, together with their respective companions, are not subject to any restriction. Their respective identification cards, whose facsimile are attached as Annexes "A" to "C," shall be honored at all times in any cinema as they discharge their mandated duties under the law.


