SUBJECT : VALIDITY OF MTRCB DEPUTY CARDS
DURING SPECIAL SCREENINGS
DATE : 22 April 2015

Deputies of the Board, including Local Regulatory Council (LRC) members or volunteers, owing to the privileged nature of their appointment and consistent with the Board's mandate to assist in the upliftment and development of the film industry, are not allowed admission as such to cinemas exhibiting film premieres or special screenings. The showing in various theaters all over the country of the *Pacquiao-Mayweather* boxing fight slated on or about **03 May 2015** (Philippine Time) is in the nature of a special screening, hence, outside of the privileges granted to deputy cardholders.

However, in keeping with the power of the Board to inspect all public exhibitions of motion pictures, and in the light of its authority to exercise such powers and functions as may be necessary or incidental to the fulfillment of its mandate, the incumbent Members of the Board, including its Chairperson, Vice Chairperson, Executive Director and organic personnel, together with their respective companions, have the unrestricted authority to inspect cinemas exhibiting film premieres or special cinema screenings. Their respective identification cards shall be honored at all times in any cinema or other venue as they discharge their mandated duties under Section 13 of P.D. No. 1986.
