MEMORANDUM

TO : **ALL CINEMA MANAGERS, PORTERS
AND TICKET SELLERS**

FROM : **MTRCB CHAIRPERSON**

RE : **WATCHLIST AND APPREHENSION OF
USERS OF FAKE MTRCB DEPUTY IDS**

DATE : **26 MARCH 2015**

Our recent monitoring of theaters showed the manufacture and use of falsified MTRCB Deputy IDs for Fiscal Year 2015-2016. Specifically, we discovered that at least two (2) MTRCB Deputy with **ID Nos. 6401 and 6200** were **falsified**.

MTRCB Deputy with **ID No. 6401** was counterfeited to make it appear as having been issued to a certain **CHRISTOPHER J. LABINE** when in truth and in fact the said MTRCB Deputy ID No. 6401 was officially and duly issued to **Board Deputy JOCELYN R. MADULID**.

On the other hand, MTRCB Deputy with **ID No. 6200** was falsified by intercalating the photograph of the suspected forger in the reproduced card that bears a semblance of the features of an official MTRCB ID. The falsified MTRCB Deputy ID No. 6200 bears the name of **RONALDO M. CADAPAN** but with a photograph different from the true and official cardholder.

Both falsified cards bear a semblance of the features of an official MTRCB ID but can easily be detected because their colors are not of the official metallic silver-gray color and they have no MTRCB hologram when subjected to an ultra-violet light.

In this connection, all cinema managers, porters and ticket sellers are hereby enjoined to be vigilant against the use of falsified MTRCB Deputy IDs. Whenever a suspected falsified MTRCB Deputy ID is presented, you are requested to observe the following:

- 1) Issue a cinema ticket to the cardholder.
- 2) Let the cardholder print and sign his/her name on the cinema tracking form.
- 3) Allow the cardholder to enter the cinema.
- 4) Keep the stub of cinema ticket presented by the cardholder.
- 5) Ensure, as much as possible, to get a CCTV footage of the identity of the cardholder and his/her companion, if there be any.
- 6) Immediately call **MTRCB Legal Affairs Division** at **0922-343-2711**, **MTRCB Monitoring and Inspection Unit** at **0920-949-2460/0920-949-2459** or **MTRCB Hotline 376-7380** for validation of the suspected deputy card.
- 7) If the deputy card is found to be spurious, immediately apprehend the suspect and wait for the arrival of the Monitoring Agents of the MTRCB, if the incident is within Metro Manila.
- 8) Bring the suspect to the nearest police authorities for the filing of appropriate criminal complaints for **Falsification of Public Document, Use of Falsified Document, Usurpation of Authority and Violation of Section 11 of P.D. 1986.**
- 9) Get sworn statements of: a) the ticket seller of the fact of issuance of cinema ticket to the suspect; b) the cinema porter of the fact of entry to the cinema of the suspect; and c) the security personnel of the fact of apprehension of the suspect.
- 10) Turn-over immediately to MTRCB the following: a) original of the cinema ticket stub; b) original of the cinema tracking form where the print name and signature of the suspect appears; and, c) copy of the CCTV footage showing the issuance of cinema ticket to the suspect and his/her entry to the cinema.

In all prosecutions concerning the falsification and unauthorized use of MTRCB Deputy IDs, the MTRCB shall always be the proper complainant.
