SUBJECT : DESIGN AND EFFECTIVITY OF NEW
DEPUTY CARDS FOR CY 2016

Pursuant to the Board's power to inspect all public exhibitions of motion pictures, and in the light of its authority to exercise such powers and functions as may be necessary or incidental to the fulfillment of its mandate (§ 13 in relation to § 3(k), P.D. No. 1986), the **new deputy cards for calendar year 2016** shall be of blue color on its face and white color on the opposite side.

The 2016 deputy card, which prominently shows on its face the name and photograph of the Deputy and exhibits an MTRCB logo watermarks when subjected to an ultra-violet light, shall be effective beginning **08 January 2016**.

In addition to the deputies of the Board, it is hereby reiterated that the MTRCB Chairperson, Vice Chairperson, Board Members, Staff, and LRC Volunteers, whose identification cards are described below, are also empowered to inspect all public exhibitions of motion pictures pursuant to § 13 in relation to § 3(k), P.D. No. 1986, as follows:


- **CHAIRPERSON -- LIGHT GRAY** color in the front and opposite sides. It bears the MTRCB logo on its front portion, as well as the photograph, ID number, name, designation and signature of the cardholder. On the dorsal side also appears the standard notice of the cardholder's admission to theaters and the name and signature of the Chairperson of the Board.

- **VICE CHAIRPERSON and BOARD MEMBERS -- YELLOW** color in the front portion and **WHITE** in the opposite side. It bears an MTRCB logo on the upper left front portion and prominently shows below it the photograph, name, designation, ID number and signature of the cardholder. On the dorsal side appears the standard notice of cardholder's admission to theaters and the name and signature of the Chairperson of the Board.
- **STAFF -- LIGHT GRAY** color in the front and opposite sides. It bears the MTRCB logo on its front portion, as well as the photograph, ID number, name, designation and signature of the cardholder. On the dorsal side also appears the standard notice of the cardholder's admission to theaters and the name and signature of the Chairperson of the Board.
- **LRC VOLUNTEERS – GREEN** color in the front portion and **WHITE** in the opposite side. It bears the name and designation, and prominently displays the photograph, of the cardholder.

Upon the effectivity of the 2016 Deputy Cards, a facsimile of which is enclosed as Annex "A," all existing deputy cards shall immediately cease to be valid.
