Terms of Reference

**For the Local Area Network (LAN)
Cabling and Rehabilitation**

I. Introduction

This project intends to rehabilitate the Local Area Network (LAN) of the MTRCB office to mend the existing cabling structure for better sharing and communication between the servers and workstations. It aims to provide the bidder a better general understanding of the requirements needed for the installation of a structured network cabling for MTRCB office. This also includes requirements for the horizontal cabling, design, engineering, and installation practices needed to satisfactorily complete the project.

II. Objectives

The objectives of this project are the following:

1. To achieve an improved network performance, simplified maintenance, increase network security, straight-forward workstation relocation and immediate network expansions. Incidental benefits would also include improved security for the network equipment as well as more flexible access to MTRCB Information and Database System (MIDAS).
2. To provide reliable structured network cabling that may reduce or eliminate the possibility of outages due to aging existing structured cabling.
3. To support the MIDAS Project through the provision of a stable and reliable network.

III. General Requirements

The Bidder shall provide the following:

1. Supply, deliver, install and configure LAN structure of the MTRCB office. All hardware must be brand new and must be intended for the Philippine market.
