In relation to the Pre-bid conference held on 28 December 2017, this Bid Bulletin No. 01 is issued to clarify, modify or amend items in the Bid Documents.

ISSUE/S	CLARIFICATIONS/AMENDMENTS
A. Administrative Overhead Margin (10%) Php3,203.90, under Item IV (C) Section VI of the Terms of Reference.	There shall be no lower limit or floor price on the amount of the bid price, pursuant to GPPB Resolution No. 14-2012 dated 01 June 2012 and GPPB Non-Policy Opinion No. NPM No. 120-2016 dated 06 December 2016. Hence, the requirement of the Administrative Overhead Margin of ten percent (10%) is removed.
B. Original copy of a bank guarantee or cash deposit certification of at least P2,000,000.00, under Item V (d) Section VI of the Terms of Reference	The requirement of Bank guarantee or deposit certificate is canceled. In lieu thereof, bidder is required to comply with the performance security prescribed in Section 39 of the 2016 Revised IRR of R.A. 9184
C. Firearms: 3 units 9mm pistol with ammos, under Item VII (A.1) of the Terms of Reference	Firearms: 2 units 9mm pistol with ammos under Item VII (A.1) of the Terms of Reference
D. Eligibility of Bidder, under ITB Clause No. 5.1 of the Bid Data Sheet	ITB Clause No. 5.1 of the Bid data sheet is hereby amended to read: 5.1 Unless otherwise provided in the BDS, the following persons shall be eligible to participate in this bidding: a) Duly licensed Filipino citizens/sole proprietorship; b) Partnerships duly organized under the laws of the Philippines and of which at least sixty percent (60%) of the interest belongs to citizens of the Philippines; c) Corporations duly organized under the laws of the Philippines, and of which at least sixty percent (60%) of the outstanding capital stock belongs to citizens of the Philippines;

	<p>d) Cooperatives duly organized under the laws of the Philippines, and of which at least sixty percent (60%) of the interest belongs to citizens of the Philippines;</p> <p>e) Unless otherwise provided in the BDS, persons/entities forming themselves into a JV i.e. a group of two (2) or more persons/entities that intend to be jointly and severally responsible or liable for a particular contract: Provided, however, that Filipino ownership or interest of the joint venture concerned shall be at least sixty percent (60%) ;</p> <p>f) The Bidder shall have the necessary experience and expertise in providing security services. For this purpose, the Bidder must submit, the following requirements:</p> <ul style="list-style-type: none"> • Certificate of engagement in the business for at least Six (6) years; • Certificate of Membership in the Philippines Association of Detectives and Protection Agency Operators (PADPAO); • Certificate of pending or no pending labor standards violation case/s issued by the National Labor Relations Commission (NLRC) and Department of Labor and Employment (DOLE); • Copy of the company profile reflecting bidder's capability to provide a minimum of four (4) qualified licensed security personnel to be assigned at MTRCB, and two (2) additional security personnel for emergency situation; and • Certification of satisfactory services rendered from at least three (3) client for the last five (5) years; • Liquidity of the contractor – at least P5 Million (Current assets minus liabilities based on Balance Sheet as of December 31, 2015).
