**INVITATION TO BID FOR THE PROCUREMENT OF TELEVISION AIRTIME AND  
TELEVISION STUDIO RENTAL FOR THE PRODUCTION AND BROADCAST OF MTRCB  
UNCUT**

The Movie and Television Review and Classification Board (MTRCB), through its available funds under Fund 151, intends to apply the sum of One Million Pesos (*Php 1,000,000.00*), being the Approved Budget for the Contract (ABC) to payment under the contract for the **Procurement of Television Airtime and Television Studio Rental for the Production and Broadcast of MTRCB Uncut**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

All qualified suppliers are invited to submit their sealed bids for the above project. Procurement will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria under pertinent provisions of Republic Act No. 9184 and its Implementing Rules and Regulations. The schedule of bidding activities is as follows:

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines. Bidders must have been legally doing business of television broadcast in the Philippines for at least ten years from the date of this invitation and must have completed, within one year period from the date of submission and receipt of bids, a contract similar to the Project.

Interested bidders may obtain further information from and inspect the bidding documents at MTRCB Bldg., No. 18 Timog Ave., Quezon City c/o Ms. Alyanna Tobia or Ms. Jesusa Lorenzo, MTRCB BAC Secretariat, anytime during office hours at telephone number 376-7380. A complete set of bidding documents may be purchased by interested bidders from MTRCB BAC Secretariat upon payment of a non-refundable fee for the bidding documents in the amount of One Thousand Five Hundred Pesos (Php1,500.00). Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that bidders shall pay the fee mentioned above for the bidding documents not later than the submission of their bids.

MTRCB reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
